SUBJECT:	Fee Waiver - 2025 Roaring Fork Kennel Club Event

**Summary:** The Roaring Fork Kennel Club (RFKC) is requesting a fee waiver for the use of various Fairgrounds facilities to host their dog show event from July 10th to 14th, which will accommodate an estimated 800 dogs. Due to prior bookings in the Event Center and Indoor Arena, RFKC has chosen to acquire auxiliary power to accommodate the needs of their event. The total non-profit rental fee for the required spaces is \$4,050. RFKC is seeking a fee waiver of all costs (\$4,050) to help offset event costs and ensure the success of this event.

**Notes:** There are fees under the purview of the Parks Department associated with the rental of Fairgrounds Regional Park (Field 4) that RFKC is requesting also be adjusted.

Fairgrounds Staff has identified an anticipated cost of \$3,200 that will be incurred since this event takes place during a period that has historically been left predominantly dark from events to allow for all the necessary facility and grounds preparations for the Fair & Rodeo.

RFKC is also requesting special accommodations to secure event dates for future years.

**Request:** The Board of County Commissioners has the sole authority to waive or reduce fees, and it may choose to waive or reduce the \$4,050 Fairgrounds rental fee for RFKC's July 10<sup>th</sup>-14<sup>th</sup> event.

AKC DOG EVENTS IN CO (2023)




An increase of 2% in dog events and 10% in dog participation from 2022, respectively.

#### **2** DISASTER RELIEF TRAILER DONATIONS



AKC Pet Disaster Relief is a lifesaving program in which AKC Reunite® partners with AKC clubs to donate trailers stocked with equipment to help create a safe, temporary shelter for at least 65 pets before, during, and after a disaster is declared. The trailer's crates and generator can be set up as colocation shelters, where owners can evacuate with their pets, as well as emergency animal shelters for displaced animals.

#### **SUPPORTING CANINE HEALTH RESEARCH**

The AKC Canine Health Foundation (CHF) has invested over **\$2.64M in canine health** research at Colorado institutions state-wide through the support of **40 projects**, research grants, and educational studies to benefit dogs. This research has spanned topics related to general canine health as well as specific projects focusing on reproductive conditions and disease, cardiology, epilepsy, hepatic disease, kidney and urological disease, musculoskeletal conditions and disease, oncology including hemangiosarcoma, lymphoma and osteosarcoma at AMC Cancer Research Center, ApopLogic Pharmaceuticals, LLC, Colorado State University, Sirius Medicine, LLC, University of Colorado, and the University of Colorado Cancer Center. There are currently 8 active grants that include projects focusing on endometritis, a clinical trial for canine mast cell tumors, a multiagent chemotherapy protocol for canine multicentric lymphoma, and a study to predict hypotension in dogs undergoing general anesthesia. CHF prioritizes a One Health and comparative medicine research approach to diagnose and treat health conditions that affect both ends of the leash while advancing canine health for all dogs.

# Local Spending Per Participants

Surveys demonstrate that exhibitors at AKC conformation dog shows spend an average of **\$982 per show weekend.** This means spending by AKC dog show exhibitors for a show weekend could inject more than **\$2.15 million\* into the local economy.** Most participants travel more than 100 miles to get to AKC events and spend at least two to three nights in the community.

#### About the Study

Our goal was to identify spending in local communities by dog lovers who attend, participate in, and host American Kennel Club events. A survey was distributed in 2021 to participants in conformation shows held throughout the US. \*The official tourism association for Orlando, FL, estimated the 2019 AKC National Championship Dog Show generated \$64 million in economic impact.

We are requesting the following fees waived for our 2025 event.

Our kennel club is making a huge investment in the County with the confidence that we can grow and put on a successful event at Douglas County Fairgrounds and Parks.

The biggest challenge with our July event is the lack of power at the Fairgrounds. In order to accommodate at least 50% of the traditional number of RV units attending our events our club is having to invest \$15,000 to \$20,000 to use portable power generators, cabling, electric panels and fuel for the July 10-14 event. Additionally, we are having to run additional cabling from the Events Center to the Parks grounds for additional electrical supply to those grounds. We are also renting \$15,000 in tenting from a local tent supplier as the Events Center is not available on one day during our event. Our club is also moving our storage rental facility from Eagle County to Douglas County.

We are requesting that we be able to hold our event annually on these respective corresponding dates and be able to rent the entire Fairgrounds, which is currently \$1,950 per day. This would enable us to utilize the existing 40+ power hook-ups, which would help us with the financials for the event. We are happy to execute a longer-term rental agreement if that is acceptable to the Fairgrounds. I have attached the economic benefits analysis as a result of hosting dog shows in Colorado. This analysis was produced by the American Kennel Club. Our show currently is held in Greeley, CO at Island Grove Regional Park. There are three dog shows held annually at Island Grove and the combined revenue just to the Park is the third largest revenue generator behind the Greeley Stampede and Weld County Fair.

As the attached reports indicate, hotels, restaurants, fuel stations, food stores, laundry facilities and other local businesses all benefit from the people attending our events. Shows typically introduce \$2 million to a local tax base. We believe Douglas County Fairgrounds and Parks can become a highly desirable destination for these events and our event will be watched by the fancy, so a successful show both in quality of facilities and costs is important to putting the best foot forward to create a splash to the canine events world. There are more than 3,000 AKC Conformation Shows annually. There are an additional 20,000 other AKC events many of which will be watching to see how successful our event is to determine feasibility of moving their events to Douglas County. Currently, there are more than 54 all-breed dog shows annually within 3 hours of Douglas County. Several of these clubs would be able to consider Douglas County for their events, but need proof of concept that the facilities can hold these sizeable shows. In addition to the conformation events, we are hosting performance events, which include a two Scent Work Trials, three Obedience Trials, and six Rally Trials during our event. We expect anywhere between 500 and 1,000 dogs at the event. This event is free to the public. 70% to 80% of our entries will come from Colorado residents.

To summarize, we need the rate relief in order to bridge the lack of power at during our first year to position us to use the full park in subsequent years.

#### **SUMMARY**

The owners of the Pine Canyon project are in the process of requesting that the property be annexed into the Town of Castle Rock (the "Town"). The development plan proposed to the Town is very similar to the plan submitted to Douglas County as the Pine Canyon Planned Development Rezoning (Project File ZR2020-010).

State statutes (§31-12-108.5, C.R.S.) require the Town to submit an annexation impact report to Douglas County prior to holding hearings on an annexation, unless the Town and the County agree that the report may be waived. The owners of the project have asked that the Board of County Commissioners agree that the report may be waived as allowed per §31-12-108.5(1), C.R.S. In light of the fact that the County has numerous plans, reports, and documents in its possession that document the potential impact of the Pine Canyon project's development in the project file for the rezoning application, waiving the impact report would be reasonable.

Re: Pine Canyon – Request for Annexation Impact Report Waiver

Dear Mr. DeBord:

This letter serves as a formal request by JRW Family Limited Partnership LLLP ("JRW") to the Board of County Commissioners of Douglas County ("The Board") asking the Board to waive the requirement for an "Annexation Impact Report" as part of JRW's annexation submittal and review to the Town of Castle Rock.

C.R.S. § 31-12-108.5 states that an "Annexation Impact Report" shall be prepared for annexations of properties larger than 10 acres from unincorporated County lands to municipalities. The statute also states that these reports shall be submitted to the Board of County Commissioners unless "the municipality and the board of county commissioners governing the area proposed to be annexed agree that the report may be waived".

In an email on December 19th, Town Staff and the Town's Attorney's Office proposed the idea of waiving this requirement to our team due to our extensive history working with the County, and County staff's in-depth knowledge of the Pine Canyon project and its would-be impacts. Our legal counsel has reviewed the situation and agreed that this option is viable and worth pursuing.

Accordingly, we request that the County please agree to waive this requirement so that we may continue to work together positively and expeditiously with the Town on an annexation and rezoning of the property.
